The Client is obligated to ensure sufficient Funds in an account specified to repayment debt (in the case the Funds will be transferred from the account at another Provider it is necessary to take into consideration a method of Funds transfer and valid deadlines for the end of year 2022 specified by such a Provider).
- (c) The last account statement as of December 30, 2022 will include accounting of interests, charges and the final account balance as of December 31, 2022.
